MEDICAL SERVICES	Medical services will be provided on official training and both days of competition. The competition hall also has AED defibrillator. The nearest hospital is very close by: UKC Ljubljana, Zaloška 2, 1000 Ljubljana.				
COVID 19	Besides the medical guidelines for the particular event, FIG also requires all the participants to follow the standard precautions. The FIG requires all participants, judges and officials to take standard precautionary measures, such as frequent hand-washing, wearing masks or face coverings at all times and keeping a physical distance of at least 1.5 metres whenever possible.				

	<p>The only situation in which the safety distance does not have to be respected is when a coach provides assistance (catch, lead, spotting) during an athlete's performance. This phase must be kept as short as possible and the assisting person is obliged to wear a mask throughout.</p> <p>Gymnasts do not need to wear a mask or face covering while they are performing at the training venue or on the FOP and keeping a physical distance of at least 1.5 metres whenever possible.</p> <p>Delegations must pay for tests if needed (depends on restrictions at the time of competition). Organiser will provide testing for the ones that need it.</p>
VISA	<p>Please verify immediately with your travel agent or the Slovenian Embassy or Consulate in your country if a visa is required for your travel to Slovenia.</p> <p>The LOC will be happy to assist each delegation member with an official invitation letter, provided if request is made before February 16, 2022. The request must include the function, full name, gender, date of birth, citizenship and passport number, passport expiry date, the arrival and departure dates of the delegation member as well as the city the visa application support letter must be sent to.</p>
INSURANCE	<p>The Host Federation, the LOC and the FIG will not be held responsible for any liabilities in case of accidents, illness (including COVID-19), repatriation and the like.</p> <p>The FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and repatriation for all the members of their Delegation.</p> <p>Basic insurance (sickness, accident and repatriation) in your country of residence is compulsory in order to be able to benefit from coverage by FIG IMSSA subsidiary insurance. Please also refer to https://www.gymnastics.sport/site/pages/medical-insurance.php for additional information regarding the FIG IMSSA insurance for Athletes and Judges. The LOC will verify the insurance coverage upon arrival of the delegation members (e.g. cover note or photocopy of the valid policy). The insurance must be valid at least starting from the arrival day of the delegation and must last for the delegations' entire stay</p> <p>The LOC will subsequently offer insurance at the Federations own charge as follows: 20€ per person per day.</p>
INTERNATIONAL TRANSPORTATION	<p>The invited participating federations must pay for the travel costs of their delegation members. The Travel Schedule Form must be returned to the LOC by March 4, 2022.</p>
LOCAL TRANSPORTATION	<p>The LOC will cover the transportation to/from the hotel from the airport Jože Pučnik in Ljubljana, Ljubljana train station or Ljubljana bus station upon arrival and by departure.</p> <p>The LOC will cover the transportation to/from M hotel to/from the Competition Hall Gimnastični center Ljubljana, Kopraska 29.</p> <p>All other transport is the cost of delegation. The LOC will be happy to find the best option.</p>

The grocery store is close by.</p> <p>The prices charged for the hotel rooms will not exceed the usual hotel rates. While the Accommodation Form must be returned to the LOC by March 10, 2022 at the very latest, the Hotel rooms will be allocated on a “first come, first serve” basis.</p> <p>The invited participating federations must pay for the accommodation expenses of their delegation members. The costs for the accommodations must be paid to the LOC by March 14, 2022 on bank account. In case of cancellation we keep 10 € per person per night.</p>																								
MEALS	<p>All gymnasts will receive lunch (sandwich and fruit) on both days of competition. For the judges and the coaches there will be warm buffet on both days. In M hotel breakfast is included in the price of the room. Every lunch or dinner is an extra 14 €. Breakfast in Sport hotel 10€, possibility to use a small kitchen for guests of hotel.</p> <p>The invited participating federations must pay for the meals expenses of their delegation members.</p> <p>While the Meals Form must be returned to the LOC by March 10, 2022 at the very latest, the costs for the meals must be paid to the LOC by March 14, 2022 in cash or by bank transfer.</p>																								
CANCELATION POLICY	<p>In case of cancellation of gymnast after March 10, we keep 10 € per gymnast from start fee and 10 € per person per night from accommodation.</p>																								
FINAL BANQUET	<p>The Final Banquet will probably not be held due to restrictions – we will inform registered delegation in time.</p>
